DATE OF THE COMMENCEMENT: 22ND DAY OF DECEMBER, 2023.

In the exercise of the powers conferred upon me by sub-section (1) of Section 89 of the District Courts Law, Cap. 42 Laws of Bauchi State as applicable to Gombe State, I, Hon. Justice Halima S. Mohammed, the Hon. Chief Judge of Gombe State hereby make the following Rules:

- 1. These Rules may be cited as the Gombe State District Courts (Increase of Fees) Rules, 2023.
- 2. The Gombe State District Courts (Increase of Fees) Rules 2015 is hereby repealed and replaced with the following:

in part, its nature and annual value shall be specified. If the annual rent or value was under stated the Court may order the balance of the fee chargeable to be paid, and if it was under stated knowingly or negligently, the court may also order a sum equal to such balance to be paid as penalty. In either case the court may direct that the proceedings shall not continue until the balance and penalty (if any) are paid.

- c) where two or more claims are join the highest fee under any relevant item shall be charged.
- d) a set-off or counter-claim shall be charged as in item 1-4 above.

In addition to the above fees, the party on whose behalf such services are to be performed shall be liable to pay such expenses of transport, as the Court may think reasonable.

For the performing of any other duty not therein expressly provided the officer may receive such fee as the Court may allow.
